Other Site Characteristics

Zona de grandes llanos con monocultivos de cereal (cebada) sin barbechos al sureste y algo más ondulado con manchas de encinar alternando con los cultivos de secano al noroeste. Márgenes de cultivos con abundancia de tomillos y salvias. Que dan refugio a especies de aves esteparias, adestacar dentro de esta zona: el aguilucho cenizo (*Circus pygargus*), el águila perdicera (*Hieraaetus fasciatus*), el Sisón (*Tetrax tetrax*), el alcaraván (*Burhinus oediceus*), la carraca (*Coracias garrulus*), la terrera común (*Calandrella brachydactyla*) o la calandria (*Melanocorypha calandria*).

4.2 Quality and importance

Se trata de la segunda área en importancia en Catalunya para el sisón (*Tetrax tetrax*). Presencia abundante de otras especies esteparias como *Calandrella brachydactyla*, *Coracias garrulus* o *Circus pygargus*.
