Other Site Characteristics

Extensa llanura con ligeras ondulaciones en la zona oriental. Se trata de un área cerealista sobre suelos pobres con alguna presencia de almendros, olivos y viñedos hacia la parte sur y este. Por la parte sur se pueden encontrar algunos bosquetes de pino blanco y encina. En esta zona encuentran refugio, alimento y nidifican numerosas aves esteparias como el aguilucho cenizo (*Circus pygargus*), el cernícalo primilla (*Falco naumanni*), el Sisón (*Tetrax tetrax*), el alcaraván (*Burhinus oedicneus*), la carraca (*Coracias garrulus*), la terrera común (*Calandrella brachydactyla*) o la calandria (*Melanocorypha calandra*).

4.2 Quality and importance

Este espacio de gran importancia en Catalunya para el sisón (*Tetrax tetrax*) en albergar la principal población de esta especie. Además, también alberga una buena población de aguilucho cenizo y de carraca.
