

This project is provided for in the Hydrological Plan for the Tajo basin, as well as in the general protocol, signed in 2009, which established the general framework for collaboration in the field of sewage and wastewater treatment, as part of the implementation of the National Water Quality Plan: Sewage and Wastewater Treatment 2007-2015.

This proyect is Co-financed by the **European Regional Development Fund ERDF 2014-2020**, within the **Spanish Multi-regional Operational Programme (POPE)**, it contributes to the conservation of the environment and cultural heritage.

With these new facilities, water purification is guaranteed even during peak flows and high season. Thanks to the contribution of the ERDF fund, the treated water will comply with the specifications of the European regulations on wastewater treatment, reducing the generation of gases and odours and minimising negative effects on both the environment and the surrounding public water domain, as well as improving water quality.

#### **Project**

The planned works consist of the construction of:

- The Wastewater Treatment Plant (WWTP) of Hervás
- Unification of wastewater discharges of the urban district of La Garganta and connection to the sewage network of Baños de Montemayor.
- Unification of wastewater discharges from the urban area of Baños de Montemayor and diversion of its current outfall to the waste water treatment plant.
- Pumping of wastewater from the Hervás industrial zone to the the new sewage treatment plant.
