

EXECUTIVE SUMMARY





















1. OBJECTIVE

This Plan is promoted by the Directorate-General for Rural Development and Forest Politics (DGDRPF), which belongs to the Ministry of Agriculture, Food and Environment (MAGRAMA), and its objective is to profit from the forest sector ability to promote socioeconomic activity, with the following main objectives:

- Contribute to the diversification of economical activity at rural areas.
- Increase the number of employments related to forest activity.
- Improve the incomes of the working people in the forest sector.
- Improve life conditions of rural area residents linked to forest activity.
- Increase the number of ordered and managed forest holdings.
- Increase the size of the forest property and attain economically efficient surfaces for a sustainable forest management.
- Contribute to a rise in the added value of forest products.
- Increase the demand for forest products.

2. MEASURES

From the study of the collected information and as a consequence of a strengths, weaknesses, opportunities and threats analysis, **85 specific measures** or actions have been defined (identifying at the end of each one of them the organisations implied in the execution of the same).

Because of their relevance, regarding the consecution of the objectives of the Plan, those measures that contribute to these **four fundamental axes** have to be **prioritised**:

- Compromise a minimum of the FEADER schedule to forest measures and define them in a useful way for the achievement of the objectives of the Plan for Socioeconomic Activation of the Forest Sector.
- Support the energetic valuation of biomass.
- Support associativism and producer organisations for the mobilisation of forest products.





- Support transformation, differentiation and diversification of use of forest resources.

The measures can be encompassed within two kinds of initiatives, depending on the organisms mainly implicated in their development:

- The measures to develop by initiative of the Administration and within its working scope belong to the following improvement areas:
 - Schedule design.
 - Development of regulations and guideline documents for its adaptation to the needs of forest sector.
 - o Forest property.
 - o Planification and sustainable management of forest lands.
 - Woodland management by means of associations.
 - o Specific physical regulation.
 - Improve coordination and cooperation between all the administrations and participation of all the social and economic agents interested in making decisions about forest environment.
 - Strengthen society forest culture through information, training and dissemination.
 - Have up to date and quality forest information available for all the Spanish land, based on common criteria and methodology.
- The measures for which the sector has to participate in an active and leading way are included in the following improvement areas:
 - Encourage utilization and mobilisation of the forest products and associated economic sectors.
 - o Associativism, contracting and transparency.
 - Mechanisation and cost reduction.
 - o Use diversification.
 - o Commercialisation and added value.
 - o Innovation.





- Improve workers training and qualification, easing professional training, contributing to productivity and competitiveness improvement of the companies in the sector.

3. CONTEXT

The Plan for Socioeconomic Activation of the Forest Sector appears like a **Coordinating Plan**, with no intention to lessen the competencies that belong to the Autonomous Communities (ACs), in which the main socioeconomic aspects of the forest sector are analysed under the global perspective for the whole territory. Hence, it is a general analysis, complementary to the ones developed, where applicable, by the ACs depending on their additional needs because of the particularities of their forest sector and their territory.

The Plan for Socioeconomic Activation of the Forest Sector (2014-2020) will be a chapter in the Plan for Diversification of the Economic Activity of the rural environment, also constituting a reference framework for the review of Spanish Forest Plan. Additionally, the content of the Plan is closely linked to the review of the Forestry Law 43/2003.

Thus, on the one hand the Plan for the Diversification of the Economic Activity of the Rural Environment –to which the Plan for Socioeconomic Activation of the Forest Sector belongs– goes after maintaining and increase the economic base of rural environment through the preservation of competitive and multi-functional activities, and the diversification of its economy with the incorporation of new activities compatible with sustainable development.

On the subject of the revision of the Spanish Forestry Plan, the Plan for socioeconomic activation of the forest sector focuses on socioeconomic aspects of the forest sector, not dealing with other important aspects that will be addressed in the future global review of the Spanish Forestry Plan, but constituting the socioeconomic reference framework for such future revision.





The review of the Forestry Law will allow to respond to measures identified in the Plan that require legislative adaptation at a national scale.

This Plan develops in a first level what is contained in the new strategy of the European Union (2013) promoting forests and forest sector, said strategy reviewing the previous one created in 1998. Thus, the Plan includes the priorities and acting aims pointed by this strategy in its socioeconomic dimension following the requests and tendencies required by actual circumstances.

Additionally, a large part of the measures included in this Plan agree with the recommendations listed in the strategic frame for Mediterranean forests, approved on 2013 during the Third Mediterranean Forest Week organised by FAO's Silva Mediterranea Committee.

Finally, it is to be mentioned that the present Plan also agrees with the vision, strategy and aims defined for the forest sector in the Action Plan for the Forest Sector in a Green Economy, approved by FAO-UNECE in the joint meeting at Rovaniemi, Finland, in December 2013.

The Plan appears like a tool for national application closely linked to FEADER schedule, one of the priorities being the orientation of FEADER measures to the aims of the Plan. Furthermore, in order to be able to carry it out, it will rely on other financial instruments.

ACs and representatives of the sector have provided their contributions to the Plan drafting, their comments have been studied and, where appropriate included in the corresponding paragraphs.

4. BUDGET

Because it is a Coordinating Plan, the Plan For Socioeconomic Activation of the Forest Sector has no specific budgetary line.





Nevertheless, the schedule for rural development 2014-2020 in agreement with the aims of the Plan will allow to set aside FEADER funds and national funds for the start up of the proposed measures.

On the other hand, the aims of the present Plan are framed within the eleven thematic objectives of the Common Strategic Framework, which means that the finances of the Plan have to rely on the rest of funds that integrate it.

Furthermore, the Plan also foresees the possibility of using other budgetary lines, identifying for each the possible fund sources.

Finally, because it is a Plan that lasts for several years, the possibility of a specific budgetary amount in the coming years is not to be dismissed, depending on the availability and the identified priorities.

5. TIME LIMIT, MONITORING AND ASSESSMENT

The Plan is valid for 7 years, after it approval, during which monitoring and assessment of its application will be performed. For the monitoring and the evaluation of the development of the actions considered in the Plan, the Plan for Socioeconomic Activation for the Forest Sector Monitoring Committee will be created, which will meet at least once a year. The Committee will be formed by a President, a Vice-president, a Secretary (with a say, but not a vote) and seven chairs:

- Presidency: Secretary-General for Agriculture and Food.
- Vice-presidency: Director-General for Rural Development and Forest Policy.
- Secretary: A representative of the Directorate-General for Rural Development and Forest Policy, with level 30.
- Chairs:
 - o Deputy Director for Silviculture and Forestry.





- A representative of the Directorate-General for Food Industry, with level 30.
- A representative of the Directorate-General for Agricultural Productions and Markets, with level 30.
- Two representatives of the ACs (annually elected in a meeting of the Directors-Generals of Forestry of the ACs convened by MAGRAMA's Directorate-General for Rural Development and Forest Policy, amongst the same ones).
- Two representatives of the sector, annually designated by MAGRAMA's Directorate-General for Rural Development and Forest Policy.

The Committee will be responsible for the assessment and start up of the actions in the Plan and for the achievement of the set goals, for which it may request information to the ACs, as well as to the sector agents. Additionally, the Committee will be in charge of directing the prioritisation of the measures, elaborating the periodic monitoring reports about the state of application of the Plan, and making proposals, where necessary, that contribute to comply with the goals.

In order to assess the put into operation of the measures foreseen in the Plan, a series of **monitoring indicators** are defined which allow for the assessment of the integration with the policies concerning the forest sector and the development of the necessary regulations. For the assessment of the start up of the Plan, an **intermediary assessment** will be performed after three years of entering into force (2017).

Additionally, once the period of validity finished, an assessment of the actions of the Plan and their effects will be performed. To do this, coinciding with the intermediate assessment, a series of result indicators will be defined that allow for the assessment of the progress made towards the achievement of every objective of the Plan. Such assessment will be performed one year after the completion of the validity period of the Plan (2021).

- A. Develop the regulation in order to adapt it to the needs of the forest sector*
- 1. Harmonise and define the minimum criteria for the forest measures in the Rural Development Programmes (RDP).

Define minimum criteria for the development, execution, assessment and monitoring of the forest measures, with a common administrative protocol for its control and, where applicable, execution, in order to include them in future Rural Development Programmes 2014-2020 (in process of negotiation).

- B. Improve coordination and cooperation between all the Administrations and participation of all social and economic agents interested in decision making about forest environment
- 3. Improve coordination mechanisms regarding forest policy.

In order to improve the coordination regarding forest policy it is required, among other actions, to keep periodical working meetings between competent Administrations, to create nationwide common guidelines, to use data models which are common to all ACs, etc.

4. Create collaboration mechanisms between the agents concerned in the sector to improve information flux (administration, forest managers, Universities, forest bodies, forest enterprises, forest platforms, NGOs, etc.).

Holding forums for interchange of information, experiences, sector needs, etc., in order to keep a constant flux of information to avoid duplicities and holes in the lines of investigation, taking advantage of the specific aptitudes and qualifications of every body concerned and directing the efforts towards those aspects that are really necessary for the users.

6. Creation of the appropriate legal and administrative instruments to foster forest management through associations.

Facilitate the grouping, for purposes of management, of owners of small forests or bigger forests on the exploitation of which economies of scale can apply.

7. Specific fiscal regulation adapted to the particular characteristics of the sector and of the forest ownership.

The formalisation of forest associations entails significant economical costs, in addition to serious fiscal loss (double taxation applied to forest owners entering into an association). It is necessary a specific fiscal regulation in order to avoid the problems emerging from these forest associations: modify corporate income tax Law so as to ensure an equal fiscal treatment of natural and legal persons concerning yields coming from forest exploitation.

8. Develop regulation for the establishment of a specific legal framework for the forests belonging to partners in co-ownership.

This is a way to motivate the management and the exploitation of forests whose owner is an owner association which, following legal requirements, needs majority agreements between owners for a sustainable management of the terrains.

Support the constitution of managing associations for forests belonging to partners, in order to encourage their management and exploitation.

Promote the constitution of managing associations in forests belonging to partners, informing the owners about the possibility of accessing to funds for this purpose through the EAFRD (Art. 36, Cooperation).

10. Apply the processes of plot concentration to the forest sector.

On one side, the unawareness of the ownership of a great amount of forest plots (many of them treeless), and on the other side, the atomisation and mosaic of the said ones with the plots which ownership is known (either public or private), make unfeasible the management and the value enhancement of a significant part of the territory and, particularly, prevent the reforestation of terrains with that vocation.





The development and the application of forest concentration as a method to ownership clarification and grouping of plots of lands would allow for the recovery for investment, management and value enhancement of a great number of hectares, and would particularly ease the reforestation of many of them by their private or public owners.

D. Provide the administrative mechanisms and instruments that encourage a sustainable planning and management of the forest terrains

Jointly promoting from the MAGRAMA and the ACs the creation of planning and management instruments which allow the owners, among other actions, to properly plan and program the works to perform on their forests, so as to profit from them while ensuring the regeneration.





11. Motivate forest planning as an essential tool to ease forest exploitation management and to improve their benefits.

The holdings having a forest management plan may be given priority, following the regulating terms of every announcement, for the bestowal of subventions and grants (investment measures), as well as for the actions foreseen in the program for rural development (articles 22, 25 of the Proposed Rules for EAFRD), or for any other actions decided according to the regulation. Sometimes (holdings bigger than a given size), it may be compulsory to have a management plan to obtain the grant.

12. Drafting and approval of common basic guidelines for forest planning and exploitation that facilitate the approval of the plans for forest management by competent autonomous administrations.

The AGE, in collaboration with the ACs, will draft and approve the common basic guidelines for sustainable forest management.

E. Promote the exploitation and mobilising of the forest products and the associated economic sectors

E.1. Promote the sustainable mobilising of wood in Spain and favour the mechanisation of the timber forest exploitation (including biomass)

Contribute to solve the main problems, of various kinds, related to the mobilising of forest products (including the biomass); intrinsic to the forest sector (product dispersion, difficulty to gain access to the same, etc.), administrative and legal (like auction procedures in the processes of extraction in forests of public interest), as well as favouring the mechanisation of the timber forest exploitation.

13. Improve the logistical network in the timber sector.

As a result of the scarcity of services and infrastructures in the rural environment, the difficulty of access to products and the resultant high transport costs, it is necessary to improve the logistical network, and therefore, the following aspects will be addressed:

a. Improvement and maintenance of the forest roads, as well as their inventory and georeferencing.

b. Evaluate the possibility of creating distribution areas or centres for wood uploading and downloading operations.

Evaluate the possibility of creating distribution areas or centres (attached to motorways and dual carriageways) for wood uploading and downloading operations, from which a distribution network to the recipients would be developed.

14. Facilitate the application for special authorisations.

Facilitate the application for special authorisations for freight transport in particular sections of the logistical network. By means of these special authorisations, it will be possible to increase the maximum allowed load in the transport vehicles for the period and section specified in the authorisation.

15. Design a network strategy:

a. Develop a machinery database (forest machinery registry),
 with owner data and even its availability.

The high cost of the machinery used in the forest sector involves an important handicap for the mechanisation of the works in the forest, although such mechanisation implies an improvement of the yields which translates into higher operating profits .

In order to invest in the mechanisation of forest work , it is necessary to have a continuity in time in the forest exploitation so as to ensure machinery amortization. The discontinuity in the works implies unavoidably the standstill of the machines, which involves a high cost by reason of which the forest exploitation is economically unfeasible.

To preventing the initial investment from becoming a hindrance for the exploitation activities and also to favour forest work, a network strategy is presented to put the forest owner or forest operator in contact with the machinery needed for the extraction of the resource.

The MAGRAMA will provide the creation of this platform by means of the diffusion of the advantages it means, performing a coordination effort of the agents involved, etc.

b. To develop a database of timber exploitation transport in which data and information about the transport and its availability are included.

Aligned with previous measure, in order to reduce transport costs, the development of a timber exploitation transport database is considered in order to put producers in touch with transporters allowing for the optimisation of transport profitability (a high percentage of trucks on their way are not fully loaded), which contributes to the reduction of CO_2 and achieves a saving in the transport price.

The MAGRAMA will promote the creation of this platform by means of the diffusion of the advantages it entails, performing an effort of coordination of the agents involved, etc.

17. Simplification of administrative processes related to forestry exploitation.

In order to ease the application and speed up the administrative processes related to activities linked with forestry exploitation (cutting, pruning, cork harvest, etc.) and other activities (repopulations, densifications, forest species changes...), MAGRAMA will coordinate a simplified procedure for those ACs wishing to apply it (such as the substitution of the authorisation for particular activities by a previous communication or shortened authorisations, where applicable, or other actions that allow for a more speeding-up processes).

18. Define the legal framework to improve the commercial quality of the forest products through the guarantee of the legality of their origin.

Developing, through a Royal Decree, the European Community regulation to combat illegal logging, needed to increase the capacity to control the cuttings and reduce the trade of illegal timber products, so contributing to improve the commercial quality of the forest products through the guarantee of the legality of their origin.

E.2. Fostering the energetic use of the forest biomass

To promote, in a general way, the exploitation of biomass coming from forest fields cultivated for this goal, as well as energetic exploitation of the forest by-products resulting from forestry, usual exploitation and forest fire prevention works. It is necessary to perform actions aimed at adapting the offer to meet the demand on exploiting the biomass and provide adequate guarantee for raw materials supply to the energetic promoters. To this effect, the collaboration of the forest Administrations with forest owners, either public or private, is required, as well as with other agents of the forest sector like highest bidders. It is also required to encourage, among other actions, the necessary regulative changes and the drafting and execution of management plans that consider the energetic use of the produced forest biomass.





21. Create basic guidelines that help planning the sustainable extraction of forest biomass out of consolidated masses and the extraction of forest biomass expected for the future through forest crops.

The actual masses are a biomass resource which, if sustainably and reasonably exploited, represents an economic resource and an opportunity to improve the forestry and ecological condition of the forests, because thinning and the clearings allow for the evolution of the forest system, the improvement of preventive infrastructures, etc. This biomass, however, is limited in time and it will likely generate a future demand that will not be satisfied unless new resources resulting from a sustainable forest management of new forest cultivations are available. This regulation has to be developed based on the best possible knowledge available, and under the precautionary criterion.

Particularly, its effects on holm oaks and cork oaks are being dramatic, having caused the loss of tens of thousands of hectares and the threat of an uncertain future for an important fraction of the Spanish dehesas and Mediterranean wooden formations. In the last decades, knowledge has been gathered about factors of predisposition, recommended management practices that should be spread and extended. But there are still deep knowledge deficiencies that can only be attenuated through a large national effort in research and development.

Expand the process of professional competences acknowledgement foreseen in the Organic Law 5/2002, of 19 June, of qualifications and professional training, which is already being applied to various fields of professional activity, like health, commerce and hotel industry, to the forest sector (including forest fires). The process consists in the assessment of professional competences of workers with expertise in a given field of activity, but who do not have the corresponding training certificates.

Thus, it is an acknowledgement to the professional expertise in a given field of activity, granted by the Administration, when workers have acquired their competences through the professional activity, not by the educating system. The accrediting is set out by means of the expedition of official certificates called "professionalism certificate", with national validity.
