siguiente:

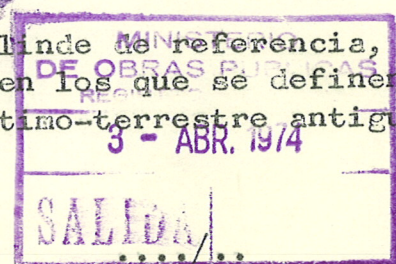
"Visto el expediente instruido de "oficio" por la Jefa-

sido deslindados los terrenos de la zona marítimo-terrestre levan-
tándose acta y plano; y que confrontado y sometido a información
pública el plano no se han presentado reclamaciones, y que son
coincidentes los límites de la zona marítimo-terrestre antigua y
actual.
