

Financial support to Environment : ERDF to EU - 25







With the new legislative package (**GR-General Regulation**) and the eligibility rules

• Article 3 'Objectives' reads in indent 1.-(...) The action taken under the Funds shall incorporate, at national and regional level, the Community's priorities in favour of sustainable development by strengthening growth, competitiveness and employment, social inclusion, as well as the protection and quality of the environment.

Cohesion/Structural Funds support innovation and environment For the next programming periode (2007-2013)

• **Objective Convergence (Article 4.3)**

– Environment, including investments connected with waste and water management, local/communal waste-water treatment and air quality, integrated pollution prevention and control, rehabilitation of contaminated sites and land and brownfield redevelopment, promotion of biodiversity and nature protection, including assistance in NATURA 2000 sites, aid to SMEs to promote sustainable production patterns through the introduction of cost-effective environmental management systems and the adoption and use of pollution-prevention technologies

Objective Convergence (Article 4.4)

Prevention of risks, including development and implementation of plans to prevent and cope with environmental risks

- Objective Regional Competitiveness (Article 5)
 - 5.1.b) (...) supporting the integration of cleaner and innovative technologies in SMEs
 - 5.2 environment and risk prevention and in particular :
 - a) stimulating investment for the rehabilitation of contaminated sites and land, brownfield redevelopment and of cultural and natural heritage, and promoting the development of infrastructure linked to biodiversity and assistance in NATURA 2000 sites contributing to sustainable economic development and diversification of rural areas

- Objective European territorial co-operation (Article 6)
 - the development of cross-border economic, social and environmental activities through joint strategies for sustainable territorial development, and primarily:
 - b) by encouraging the protection and joint management of the environment;



Regional Policy Governance/ Community Strategic Guidelines

EUROPEAN COMMISSION

•Regions are encouraged to develop regional sustainable development strategies, building consensus on the objectives to be achieved through regular and systematic dialogue with key stakeholders.

•Partnership is essential to the elaboration and the implementation of development strategies



Regional Policy

Governance/ Community Strategic Guidelines

•Consultation and participation of stakeholders: competent authorities, economic and social partners, and representatives of civil society including non-governmental organisations.

 Partnership provides a basis for openness and transparency in the preparation and implementation of programmes



Innovation / Community Strategic Guidelines

- Investments in innovation represent the overarching priority for cohesion policy and their co-financing should be the main priority in the regions covered under the Regional competitiveness and employment objective.
- Even though substantial amounts of money will have to be used for improvements of the infrastructure in <u>convergence regions</u>, innovation is also their pathway to the <u>future</u>.



SF and SMEs 2000-2006

- Circa € 20.3 billion for SMEs' development of which:
 Circa € 1.3 billion for risk capital financing for SMEs
- Circa € 9.6 billion to research, technological development and innovation

Regional Policy

- Making regional RTD innovation and education supply more efficient and accessible to firms, in particular SMEs (for example, "poles of excellence" or clusters);
- Providing business support services (preferably through public-private-partnerships and one-stop-shops);
- Ensuring full exploitation of European strengths in the area of eco-innovations;
- Promoting entrepreneurship, facilitating the creation and development of new firms, and promoting spin-out and spin-off companies from research institutions or firms using a variety of techniques.

Spain is catching up

 Spain should take advantage of the new generation of the cohesion policy programmes to shift from a growth model based on low labour costs and low value added activities

to a sustainable development pattern more focused on innovation

in order to be able to generate and attract investments, find new market niches and compete in international markets with higher value added products and services
