Forum for **dialogue**, **cooperation and institutional coordination** among the responsible persons for the environmental inspection: State and Autonomous Communities.

-**Promote the cooperation** and experience exchange among the members.

-Permanent Forum to exchange knowledge in relation with the environmental inspection.

-Focus on

- \rightarrow inspections to the **industry**.
- → Inspections on waste **shipments**
- \rightarrow how to involve CCAA in impel **projects**

-Formal Network.

- \rightarrow Secretariat, Plenary and executive Commitee.
- → One vote per member. Members are the responsible persons for environmental inspection, appointed by the environmental authority and one member representing the Environmental Ministry.

-Open. To external collaborators (ENAC).

-Meeting point. Look for the consensus. Agree by consensus (if it is not possible, for majority), the projects to be developed.

REDIA NETWORK

Plenary: All members. At least one meeting per year

- Approve, modify and set the statutes
- Approve the annual program to develop during the next year
- Approve new proposals of projects.
- □ Secretariat: Ministry of Environment.
 - Diffusion of information: Plenary meeting, WEB page, CIRCA, e-mails

New Directives and Laws related to inspection REDIA projects and questions IMPEL projects and questions

- Processes forms for participation in REDIA
- Writes the minutes

- Represents REDIA in IMPEL annual meeting and promote the participation of its members.
- Executive Committee: President & Secretary + 3 plenary members
 - Promote new projects and accept proposals
 - Develop projects with the participation of members (at least 3).
